How it Works

1 AI-Powered Detection

Counterfeit and unauthorized listings are identified across global marketplaces using image matching, pricing anomalies, keyword misuse, and seller behavior.

2 Evidence-Backed Removal

Takedown requests are submitted through marketplace trust and safety channels with supporting evidence to improve speed and reduce rejections.

3 Re-Listing Suppression

Seller networks are tracked across marketplaces to detect and flag re-listings, preventing fraud from reappearing after removal.
